
## **Bill Engvall**

His understated delivery and borderline surrealistic wordplay makes him that rarest thing in comedy - a true original.




## Joseph and Holly Kincannon

FILTICE Congress shall make no law respecting an establishment of religion, or pro-hibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances. the right of the people to keep and bear arms, shall not be infringed. Ttick III. No soldier shall, in time of peace, be quartered in any house, without the consent of the owner, nor in time of war, but in a manner to be prescribed by law ..... effects, against unreasonable searches and seizures shall not be violated, and no warrants shall issue, but upon probable cause, supported by oath or affirmation, and particularly describ-ing the place to be searched, and the persons or things to be seized. rticle famous crime, unless on a presentiment or indictinent of a grand jury, except in cases arising in the land or naval forces, or in the militia, when in actual service in time of war or public danger; nor shall any person be subject for the same offense to be twice put in jeopardy of life or limb; nor shall be compelled in any criminal case to be a witness against himself, nor be deprived of life, liberly, or property, without due process of law; nor shall private property be taken for public use, without just compensation. Tick VI. In all criminal prosecutions the accused shall enjoy the right to a speedy and public trial, by an impartial jury of the state and district wherein the crime shall have been committed, which district shall have been previously ascertained by law, and to be informed of the nature and cause of the accusation; to be confronted with the witnesses against him; to have compulsory process for obtaining witnesses in his favor, and to have the assistance of counsel for his defense. The right to bear arms and the presumption of innocence both put the government on notice as to who is the master, and who the servant in our Republic, as timely a message today as ever.


